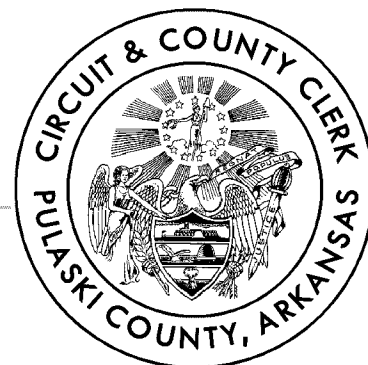

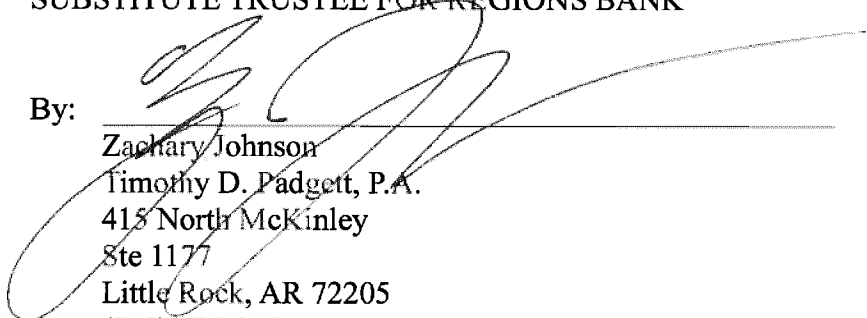
WHEREAS, there may be tenants that claim an interest in the real property herein based upon said tenancy; and

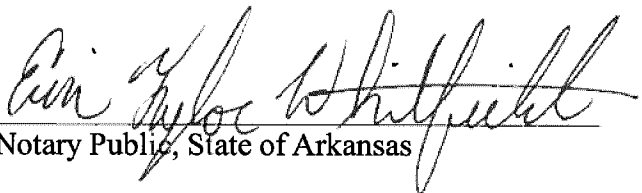
